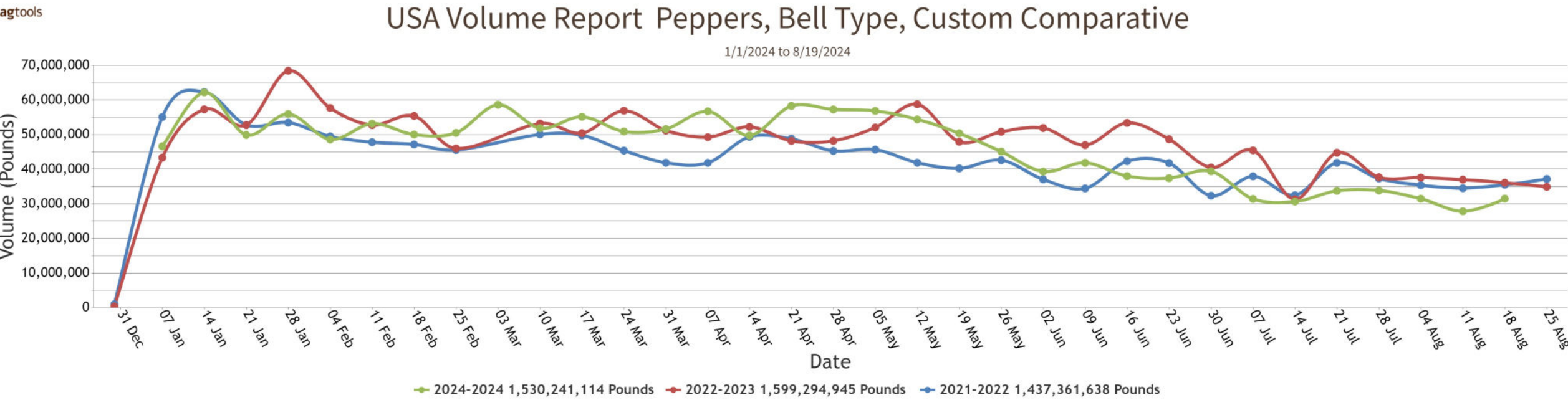

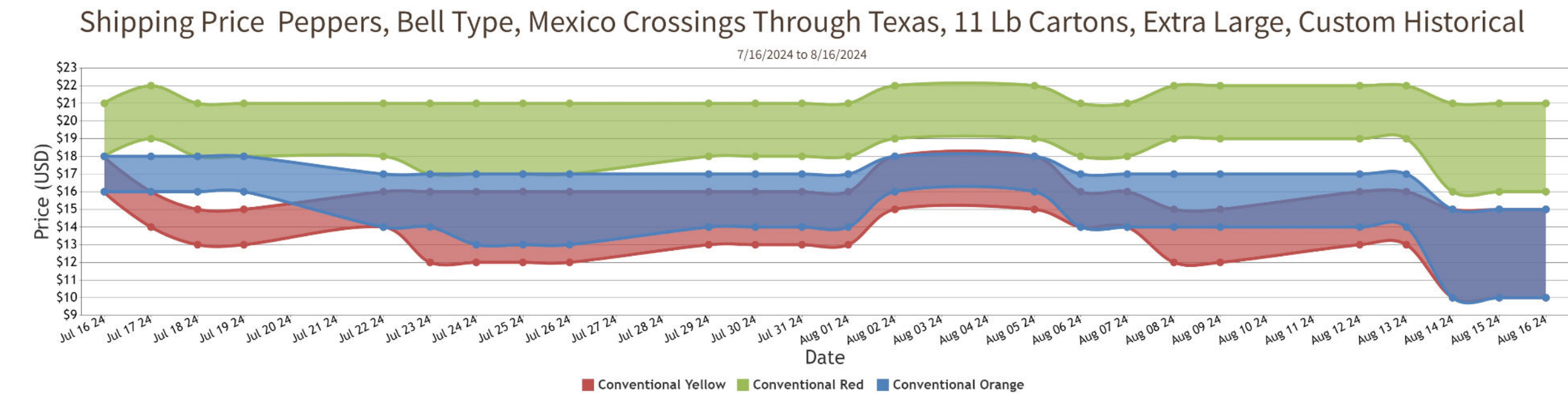


# Bell Peppers

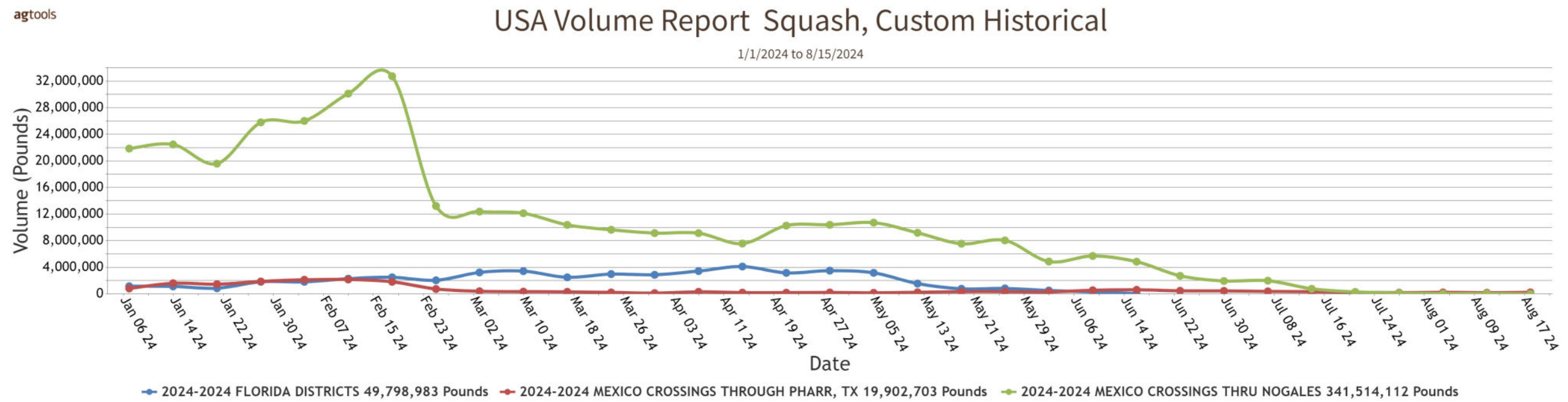

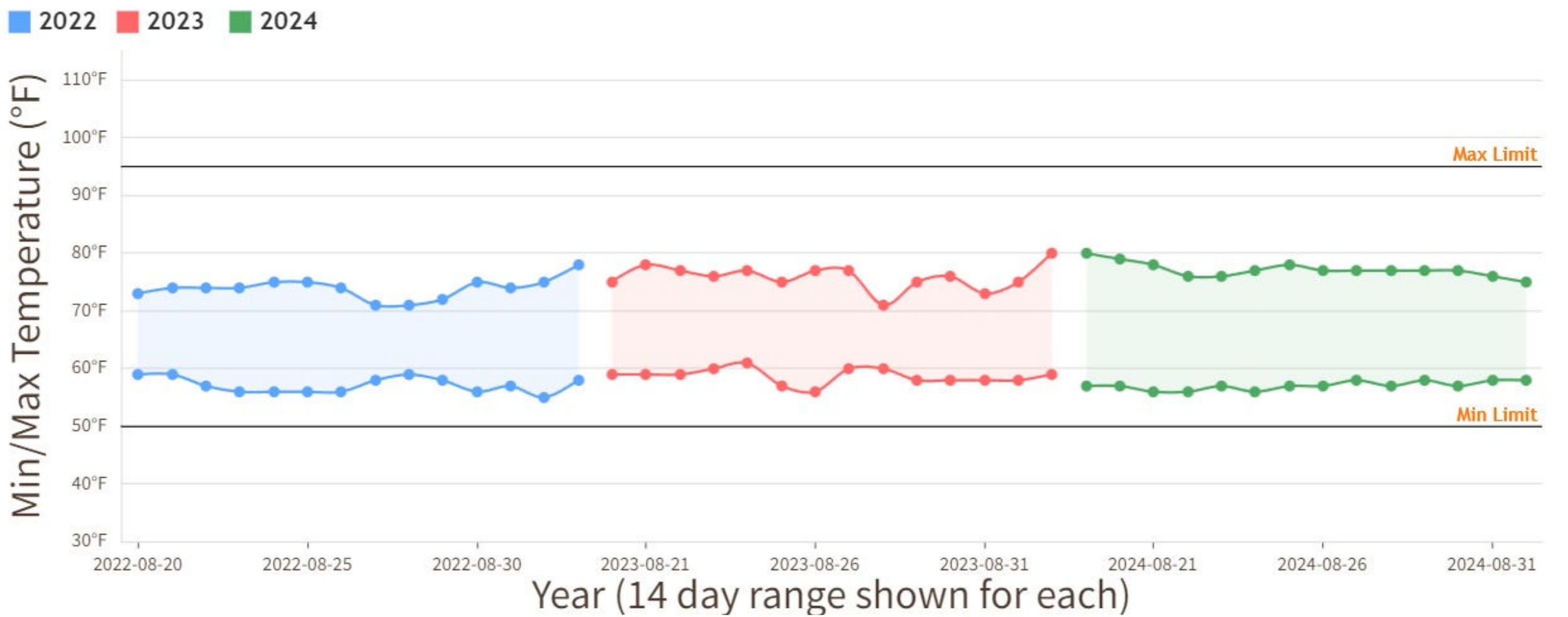
