Unless otherwise stated, shipments, crossings or imports are for the weeks ending July 20, 27, and August 3, 2024, in that order in thousand hundredweight (cwt) or 100,000-pound units. The expected movement is for the period August 4-17, 2024. Prices are for Monday August 5, 2024, compared to Monday July 29, 2024. Unless otherwise stated, sales are F.O.B. Shipping Point Basis (including Delivered Sales, F.O.B. Shipping Point Basis) or port of entry, and extra services are included. Prices represent open (spot) market sales by first handlers on products of generally good quality and condition unless otherwise stated and may include promotional allowances or other incentives. No consideration is given to after-sale adjustments unless otherwise stated. Brokerage fees paid by the shipper are included in the price reported.
